


# Malaysia Secondary Sources

This guide provides information on how to search for Malaysia Secondary sources (including commentary, current awareness and Asian Legal Business Journal on Westlaw International – Asia. It also demonstrates some efficient tips via a task-based search example.

### **Accessing Malaysia Commentary**

- 1. Access Malaysia Commentary by Jurisdiction:
  - Go to the Asia Home Page
  - Select Malaysia as the jurisdiction
  - Then, choose Commentary as the Content type
- 2. Access Malaysia Commentary by Content type:
  - Go to the Asia Home Page
  - Select Commentary as the Content type
  - Then, choose Malaysia as the jurisdiction






#### Malaysia Commentary Advanced Search Template

The Advanced Search Template provides search fields specific to commentary. Enter keywords into one or more fields to find the required commentary services. For helpful advice on searching, click Search Tips in the top right corner.

- 1. Click on **Advanced** next to the search bar to display the Advanced Search Template which provides various search field options.
- 2. Click on **Search Tips** at the top righthand corner for tips on running a more effective search, including how to search with plain language, and how to use Boolean Terms & Connectors.
- **3.** Use one or more of the search fields in the Advanced Search Template to search across commentary, including **Key Search Terms** and **Paragraph Number**.
- 4. Search with Connectors and Expanders in the Key Search Terms field to increase the efficacy of the search.





This example demonstrates how to find commentary on Anton Piller Order.


- 1. Navigate to the Malaysia Commentary Advanced Search template, as explained above.
- 2. Type "Anton Piller Order" with Terms & Connectors in the Key Search Terms search field to search the exact phrase.
- 3. Click **Search** or press Enter.

  - Then, choose Malaysia as the Jurisdiction






# Malaysia Current Awareness Advanced Search Template

- **4.** Search with **Connectors and Expanders** in the **Key Search Terms** field to increase the efficacy of the search.







#### Searching Malaysia Current Awareness

This example demonstrates how a Banking and Finance lawyer conducts a search for latest developments in relation to **Islamic bond** or **sukuk**.

- 1. Navigate to the Malaysia Current Awareness Advanced Search template, as explained above.
- 2. Type "Islamic bond" or sukuk in the Key Search Terms search field.
- 3. Select Banking and Finance from the Subject dropdown menu.
- 4. Click Search.
- 5. Use the Sort by function and select Date (Newest first).








## **Accessing Malaysia Journals**

- 1. Access Malaysia Journals by Jurisdiction:

  - Select Malaysia as the jurisdiction
  - Then, choose Journals as the Content type
- 2. Access Malaysia Journals by Content type:
  - Go to the Asia Home Page
  - Select **Journals** as the Content type
  - Then, choose Malaysia as the Jurisdiction






#### Malaysia Journals Advanced Search Template

- 4. Search with Connectors and Expanders in the Key Search Terms field to increase the efficacy of the search.





#### Searching Malaysia Journals

This example demonstrates how to find 2024 articles relating to AI Governance in the Asian Legal Business Journal.

- 1. Navigate to the Malaysia Journals Advanced Search template, as explained above.
- 2. Type "Al Governance" with Terms & Connectors in the Key Search Terms search field to search the exact phrase.
- 3. Type "Asian Legal Business" in the Journal Title field and "2024" in the Publication Year field.
- 4. Click **Search** or press Enter.
